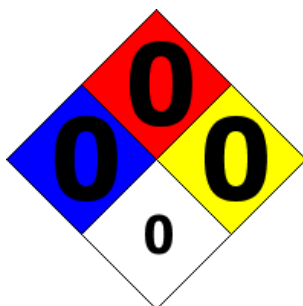

#### Description of first aid measures
